**(This Notice of Renewal is applicable only for the Registered Medical Practitioners who have been registered themselves during the period 01.01.2016 to 31.12.2016)**

Notice is hereby given to all 5484 Registered Medical Practitioners, whose names were registered in the Medical Register from 01.01.2016 to 31.12.2016, maintained under the Maharashtra Medical Council Act, 1965 and those Registered Medical Practitioners who has not renewed their Registration till date, they have to submit an application by online in prescribed form to the undersigned, for renewal of registration as provided under Section 23(a) of the Maharashtra Medical Council Act, 1965 and Amendment Act, 2003.

Online application form is available on Maharashtra Medical Council's website [www.maharashtramedicalcouncil.in](http://www.maharashtramedicalcouncil.in).

After, completing online renewal procedure and online payment submit the following documents with online Application Form, duly filled in, by Post/Courier/ to Maharashtra Medical Council office in Mumbai.

- Hard copy of Application Form of Renewal of Registration.
- Undertaking Certificate (Original duly signed)
- Two recent Passport Size Photographs.
- Self-attested photocopies of relevant CME Certificates. As per the Indian Medical Council (Professional conduct, Etiquette and Ethics) Regulations, 2002 Chapter 1 Clause B Sub Clause 1.2.3. every Registered Medical Practitioner have to earn 30 credit hours every five years by way of attending CME/Workshop/ Conference/ International Conference / Online CME.
- Self-attested photocopies of Permanent Registration Certificate and Additional Qualification Certificate ( If any.)
- Self- attested photocopy of Aadhar Card.
- Renewal of Registration, not done 90 days then submit Notarized affidavit on Non Judicial stamp paper of 100/-Rs.
- Renewal of Registration, not done within 90 days then submit Notarized Indemnity bond on Non-Judicial stamp paper of 200/- Rs.

**Note :-** Renewal late fee as applicable of Rupees Five Hundred through online payment portal.

Separate individual notice will not be sent to the Medical Practitioners for Renewal of Registration.

The Registered Medical Practitioners, who fail to apply for renewal within a specified time period, may face the legal consequences thereof.

On the receipt of required documents at Maharashtra Medical Council office, your registration will be renewed.
