CIRCULAR

Sub: - Regarding Permanent Registration.

Preamble: -

In view of COVID-19 pandemic and lockdown situation and to augment number of health care professionals in management of covid patients in Government Medical Colleges/Municipal Medical Colleges/Government Health Centres, Maharashtra Medical Council has taken following measures to issue Permanent Registration to students who have complied with online requirement for Permanent Registration on an urgent basis.

- 1) Registration number will be provided immediately to all applicants who have completed online application formalities including payment.
- 2) Council will issue registration number and e-digital certificate to RMP's email immediately on receiving online application.
- 3) Verification of documents and fulfilment of legal criteria will be done by MMC subsequently, after which physical hard copy of registration certificate will be sent by speed post as per the procedure. Council shall add a footnote on the E-Certificate stating that, this registration shall be subject to verification of documents and fulfilments of all legal criteria.

This procedure is adopted by MMC so that registration number would be made available to all candidates who have applied online immediately to facilitate their legal practice in medicine.

Applicability: -

This circular shall be applicable to students who have passed MBBS examination and completed their rotatory internship from the state of Maharashtra.

Interpretation: -

This circular shall come into force with immediate effect. If any issue arises regarding interpretation of the circular, Hon'ble President has authority to deal with these issues.
