GUIDELINES AND CRITERIA FOR MAHARASHTRA MEDICAL COUNCIL AWARDS-2015

Nomination form will be available online with online filling of the same. **Nomination from local IMA/ Speciality organizations / Institution Heads will only be accepted.** No fees are required to be paid. In case there is no organization of the doctors then and in exceptional circumstances individual application could also be entertained based on merit.

All certificates/credentials to be uploaded or given in hard copy to Maharashtra Medical Council, Mumbai.

(a) Ethical and Scientific Practice.	
(b) Social involvement with commitment.	
<u>Social Issues</u>	
	I. Working for empowerment of women / orphan/ Sr. Citizen and their health issues.
	II. Working in backward / naxal / malnourished areas.
	III. Inculcation of values and National character in children.
(c)	Other criterion with definite marking system on various heads (sheet to be prepared).RMPs can mention the field of their excellence which is approved by nominating NGO/organization.
VI	Category
	(a) Resident Doctors working in Medical Colleges. Nomination by local unit of MARD. Not more than two nominations from each branch, one for male resident doctor, one for female resident doctor.

<ul style="list-style-type: none"> • Work with dedication • Research for community based problem. • Extra Curricular Activities. <p>(No Accreditation of council required)</p>	
<ul style="list-style-type: none"> • Nominating organizations may undertake suitable exercise as deemed fit to make final selection for the nomination at their level. • The nomination will be scrutinized and short listing will be done in 1:3 ratio final selections and shortlisted candidate may be required to attend the interview at specified place and time at their own cost. • Number of Awards in each category will be two (One for male and one for female RMPs). 	
<ul style="list-style-type: none"> • Nature of Award Rs. One Lakh cheque, Citation, Shawl, Shreefal and Bouquet. 	

<ul style="list-style-type: none">• Selection by Retired High Court Justice.
<ul style="list-style-type: none">• Advertisement of awards in all prominent News Papers of Maharashtra and letter to all accredited organizations, inviting applications on a prescribed format available on the MMC Website
<ul style="list-style-type: none">• Awards will be given at the hands of His Excellency Governor of Maharashtra and / or the Chief Minister of Maharashtra at Nagpur/Mumbai in the presence of Medical Education Minister and other dignitaries.
<ul style="list-style-type: none">• Only RMPs with up-to-date Renewal Status with good standing with Maharashtra Medical Council will be considered
<ul style="list-style-type: none">• Persons who have not received awards for the same work may be preferred.

It is better to apply online, uploading all the details, to enable to reach in time. However application can be made in hard copy along with the annexures to make it reach within the stipulated time.
